

The **ipin** (International Player Identification Number) is brought to you by the International Tennis Federation, the world governing body of tennis.

All players who wish to compete in ITF Junior Circuit, ITF Pro Circuit or ITF NEC Wheelchair Tennis Tour tournaments are required to have a current IPIN Membership.

All Seniors players may now register for an IPIN. Seniors players who wish to compete in 2012 ITF Seniors Circuit Tournaments are required to have Seniors IPIN membership.

As well as allowing players to play in ITF tournaments, IPIN Membership provides access to the IPIN Online Service which helps you to manage your tennis career and keeps you up-to-date at all times! Pro Circuit players can also use the service to manage their tournament entries online.

1. Agreements of the Player

I declare that I am aware of and will abide by the Rules of Tennis, as approved by the International Tennis Federation, the ITF Pro Circuit and/or ITF Junior Circuit and/or ITF Seniors and/or ITF Wheelchair Tennis Regulations and Code of Conduct, as amended from time to time by the ITF Men's and Women's and/or Junior and/or Seniors and/or Wheelchair Tennis Circuit Committees (the "Rules"). The Rules include, but are not limited to the Age Eligibility Rule; the ITF Tennis Anti-Doping program; the Uniform Tennis Anti-Corruption Program and the ITF Player Welfare Policy. Finally, I understand that this agreement will remain in full force and effect until I further advise the ITF in writing that I am permanently retiring from participation in tennis with immediate effect.

Waivers

I understand that there are inherent risks involved in my participation in ITF Tournaments, including, but not limited to, those associated with other conditions, playing conditions, equipment, other participants and spectators. I fully understand the risks associated with my participation in the Tournaments. To the full extent permitted by law, I hereby waive any and all claims, demands, damages, losses, costs, expenses, attorney's fees, and other legal obligations that I or my legal representatives may have against the ITF, its officers, employees, authorized agents, and independent contractors, for any loss or damage that is incurred with any decision, ruling or action of the ITF or its officers, employees, authorized agents, or independent contractor with respect to my participation in ITF Tournaments.

5. Minor Medical Release - Players under 18 years of Age

Please ensure that your parents and/or legal guardian have read this release in relation to medical emergencies involving you.

When participating at the Tournaments, if any emergency arises involving the physical or psychological well-being of the player and, at such time I (or any other legal guardian of the player) am not immediately available, I hereby give any Tournament appointed official, tournament physician and/or Sports Medicine Trainer full permission and authority to take such steps as are medically reasonably necessary to protect and assist the player. I agree to pay any hospital expenses, physician bills or any other expenses incurred as a result of any such medical emergency. In non-emergency situations, I hereby give any Tournament appointed tournament physician and/or Sports Medicine Trainer full permission and authority to administer standard on-site treatment as needed, including, but not limited to, standard athlete training treatments, medical care and physical therapy. I understand that such standard treatments may also be administered off-site during the Tournament week at the official Tournament hotel by the Tournament appointed tournament physician and/or Sports Medicine Trainer. Finally, I understand that this Minor Medical Release will remain in full force and effect until the eighteenth (18th) birthday of the player or until I further advise the ITF.

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. Save where the Rules provide for another court or tribunal to have jurisdiction, the parties agree to refer any dispute arising out of or in connection with this Agreement to the Court of Arbitration for Sport for final and binding arbitration in accordance with the CAS Code of Sports Related Arbitration.
